GENERAL INFORMATION

Mayor Pro Tem Skeries solicited quotes from J&M Fireworks for the Windsor Heights Fall Festival, scheduled the weekend of October 7th, 2023. J&M is a reliable contractor and works well with our Public Safety team, staff and community events committee members. Two price levels are presented: \$13,000 and \$15,000, and the higher the price the greater number of shells that are fired. We already receive a 15% bonus in shells for being repeat customers (loyalty program) and will receive an 8% bonus for paying early.

The community events committee met on March 17th and Councilor Skeries solicited responses on what price level should be recommended to Council. Of the five responses, four recommended the \$15,000 level, with the fifth recommending the \$13,000 level. This recommendation of \$15,000 was primarily based on the positive feedback received after last year's Fall Festival, when we spent at that same level.

SUMMARY

I would ask Council to consider the two price levels for fireworks and authorize staff to purchase said recommended level.
